

**VILLAGE OF MOUNT PROSPECT  
APPLICATION FOR 2014 PROPERTY TAX RELIEF GRANT**

Any current resident of the Village of Mount Prospect who is the **owner and occupant** of a single-family residential unit and whose income does not exceed certain income guidelines may be eligible for a Property Tax Relief Grant as authorized under Article XIV of Chapter 8 of the Mount Prospect Village Code.

To qualify for the 2014 grant, the maximum income for a one-member family unit is \$23,340. The maximum income for a family unit of two or more is \$31,460. The grant amount will be fifty percent (50%) of that portion of the 2013 real estate property tax, up to a maximum of \$100.00, levied by and on behalf of the Village and paid by the applicant.

A copy of ***the 2nd installment of your 2013 Real Estate Tax Bill***, a signed copy of your 2013 Federal Income Tax Return (if filed), and a copy of your Social Security benefit statement (Form SSA 1099) for 2013 must be included with this application.
