IT IS HEREBY ORDERED:

1. The Village of Mount Prospect agrees to withdraw its emergency motion for a Temporary Restraining Order; and
2. Prestige Feed Products, LLC shall be allowed to operate its facility located at 431 Lakeview Court, Mount Prospect, for additional hours, including during daytime hours, mutually agreed upon by the Parties during the period of December 13, 2023 through January 8, 2024; and Prestige Feed Products, LLC shall provide the Village with a written operations schedule for the period of December 13, 2023 through January 8, 2024 as soon as it can do so; and
3. The Village of Mount Prospect shall monitor the compliance of Prestige Feed Products, LLC with applicable Mount Prospect Municipal Code provisions during the period of December 13, 2023 through January 8, 2024; and

4. The Parties agree to stay all written discovery and depositions related to their pending motions for preliminary injunction until January 8, 2024; and
5. The Parties shall appear before the Court for a status hearing on **January 8, 2024, at 9:30 a.m.**, before Judge Quish via Zoom at 953 7174 953; Password: 253498; Call-in: (312) 626-6799.
